### **Audit Interviewing Best Practices**

#### **Session Abstract**

This presentation and discussion focuses on best practices for <u>audit interviews</u>. Audit interviews can take many forms, but usually have the objective of obtaining information from a client, or auditee, in order to understand and document business processes in an organization. This presentation discusses preparing for an audit interview, performing an interview, techniques for confirming the information obtained, and procedures for follow-up and documentation of the information.

Audit interviewing should be distinguished from job interviewing, which has a different objective of finding good candidates to hire, and from fraud interviewing, which also has a different objective, usually to find out details of an unscrupulous event that has occurred and/or to determine the guilt or innocence of a suspect. Instead, in an audit interview, the auditor usually seeks to obtain information in a non-persuasive and non-contentious manner. The format for the presentation will be a group discussion led by the presenter. All participants will be encouraged to freely contribute their experiences and to share their best practices.

#### **Target Audience**

This session is beneficial for auditors at all levels and across all industries, especially auditors who work with business processes and internal controls.
