- Fusion Applications protect personally identifiable information (PII)
- PII = any piece of information which can potentially be used to uniquely identify, contact, or locate a single person.
 - Social Security Number (SSN)
 - Driver's license number
 - State or National Identifier (Identification Card number)
 - Passport Number
 - Account number, credit card number (CCN) or debit card number
 - Home or Physical address (e.g street address)
 - Email address
 - Telephone number

Database Vault

- Realms around sensitive schemas or objects
- Restrict DBA access to realm data
- Support multi-factor SQL command rules
- Enforce separation of duties
- Block threats targeting privileged DB accounts
- Restrict all access unless explicitly authorized with Mandatory Realms (New)
