## Conducting Enterprise-wide IT Risk Assessments

## **Abstract:**

Essential to IT governance and IT audit planning is a comprehensive process for managing IT risks. A risk management framework helps ensure integration of business, operational, and IT risk management, risk assessment, and risk mitigation strategies. Furthermore, formal risk management establishes a common and agreed-upon level of IT risks, mitigation strategies, and accepted residual risks. A key component of risk management is a comprehensive risk assessment process. On a recurring basis, IT risks should be re-evaluated to assess the likelihood and impact of all identified risks using qualitative and quantitative methods. Furthermore, the probability and impact associated with inherent and residual risk should be determined individually, by category, and on a portfolio basis. This session will discuss a methodology for completing an enterprise-wide IT risk assessment in highly decentralized and diverse environments. Session attendees will be provided with access to templates and references to resources that can be used immediately to conduct enterprise-wide risk assessments in their organizations.
