#### Session Synopsis

In the current environment of ever-evolving cyberthreats and ever-larger databases of personal information, security breaches are, unfortunately, inevitable for most organizations. That is why it is crucial to develop and implement a thoughtful security incident response plan. This presentation will review the reasonable steps that all organizations can take to ensure that they are prepared to respond promptly and effectively to potential breaches when they occur. The presentation will review:

- \* State and federal breach notification laws;
- \* Best practices for incident response plans;
- \* Privacy by design principles;
- \* Common mistakes in breach response; and
- \* How to manage the first 24 hours after discovery of an incident.

Sharon clerked for the California Supreme Court and taught Cyberlaw and Privacy at Golden Gate University School of Law.

A frequent industry speaker, Sharon serves on the Department of Homeland Security's Data Privacy & Integrity Advisory Committee, as well as on the Compliance, Privacy and Audit Committee of El Camino Hospital's Board of Directors, the Future of Privacy Forum's Advisory Board & many other panels. Sharon is the co-inventor of a privacy indicator method patent (pending).
